The Service includes Reiki sessions for the amount of time agreed upon by the Client and Leah, at the rate of \$30 per 15-minute session, with the addition of \$0.67 per mile for the round-trip distance from Leah's Glendale address.

_____ I understand that Reiki is a hands-on practice and I give Leah permission to use gentle touch during my animal's session. If your animal shows aggression or has behavioral issues, you will need to keep them on a leash or contained during the session. Leah will then use a distant healing method.

_____ Animals are sensitive to energy and, therefore, they may react differently than their normal behavior during their session. Most animals become very relaxed and fall asleep. Your animal may pant, circle around the room or seem uneasy. Moving the energy can feel puzzling for them but Leah will make sure they are as comfortable as possible.

_____ If your animal shows aggression during the session, Leah reserves the right to discontinue working on them for her safety and for the animal's.

_____ I understand Reiki can enhance the overall wellness in my animal; however, it is not a replacement for veterinary care. The Client understands that Leah does not diagnose conditions nor does she prescribe or perform medical treatment, prescribe substances, nor interfere with the treatment of a licensed medical professional. Leah cannot promise that Reiki will completely heal your animal, although she will do everything in her power to make your animal as comfortable as possible.

____ I understand it can take a few sessions before I begin to notice a change in my animal's behavior or health.

_____ I understand that by signing this release, the Client hereby agrees to release Leah from any and all claims Client may have for any injury, disability, death, damages, liabilities, expenses, costs and/or causes of action attributing or relating to Leah's entry upon the Property and participation in the Service, whether caused by the negligence of the Client or by any other reason.

Payment is due at time of rendered Service. Client agrees to pay Leah \$30 per 15-minute session. Travel time & expenses are included in this rate up to 10 miles. A surcharge of \$0.67 will be charged per mile for the round-trip distance from Leah's Glendale location to the Client's address.
